A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WILLIAMS DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD ON NOVEMBER 4, 2008, AND SETTING FORTH A STATEMENT OF THE ELECTION RESULTS

WHEREAS, a General Municipal Election was held in the City of Williams on Tuesday, November 4, 2008, for the purpose of electing two (2) City Council Members – Full Term, and a City Clerk – Full Term, and a City Treasurer – Full Term; and,

WHEREAS, by Resolution 08-12, adopted by the City Council of the City of Williams on July 9, 2008, and said City Council requested the Board of Supervisors of the County of Colusa, State of California, to permit the Colusa County Clerk to render the following specified services:

- 1. Publish all legal notices.
- 2. Verify signatures on candidate's nomination papers.

- 9. Perform all other duties required by State Law pertaining to the conduct of said election except issuing and filing of candidates' nomination papers and administering the applicable provisions of the Fair Political Reform Act of 1974 as amended.

WHEREAS, the said Colusa County Clerk, pursuant to authority granted by the said Board of Supervisors, has conducted the election and furnished the specified services above described; and,

WHEREAS, it appears that notice of said election was regularly given and the election was held and conducted in accordance with provisions of the elections Code of the State of California; and,

WHEREAS, the Colusa County Clerk, on November 14, 2008, certified to the City Council of the City of Williams that the votes cast in the consolidated elections were as follows:
