

**RESOLUTION No. 09-34**  
**A RESOLUTION OF THE CITY COUNCIL OF**  
**THE CITY OF WILLIAMS AWARDING A CONSTRUCTION CONTRACT TO**  
**SYBLON REID FOR THE CITY OF WILLIAMS**  
**WASTEWATER TREATMENT PLANT IMPROVEMENTS 2009,**  
**PROJECT NO. WILL08-003, CLEAN WATER STATE REVOLVING FUND**  
**PROJECT NO. C-06-4049-110**

**WHEREAS,** The City received and accepted the construction proposal for the subject construction contract from Syblon Reid, and

**WHEREAS,** In July 2009 the City Council gave a conditional award for the subject contract to Syblon Reid, and

**WHEREAS,** The condition of the award was the receipt of funding from the Water Resource Control Board's Clean Water State Revolving Fund, and

**WHEREAS,** The contractor has extended his bid proposal until the middle of January 2010, and

**WHEREAS,** Starting January 1, 2010, many subcontractor, labor, and material suppliers to the contractor are subject to rate and cost changes, and

**WHEREAS,** By awarding the contract before the end of the year the City will be able to avoid significant construction cost increases and the contractor will be able to commence the project earlier, and

**WHEREAS,** The funding commitment from the State Water Resources Control Board was received on December 1, 2009, documented in the State Water Resources Control Board Resolution No. 2009-0086, and

**WHEREAS,** Funding commitment amount from the Clean Water State Revolving Fund is \$17,000,000, and

**WHEREAS,** The contract amount total to complete the Wastewater Treatment Plant project is \$13,295,900.

**NOW, THEREFORE, THE CITY COUNCIL FOR THE CITY OF WILLIAMS, CALIFORNIA RESOLVES THAT:** that the City Council award a construction contract to Syblon Reid for the City of Williams Wastewater Treatment Plant Improvement 2009, Project No. WILL08-003, Clean Water State Revolving Fund Project No. C-06-4049-110.
