**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WILLIAMS
ADDING A FINE FOR VIOLATION OF THE
PERMIT PARKING PROGRAM TO THE SCHEDULE OF
CIVIL PENALTIES FOR PARKING VIOLATIONS**

WHEREAS, City of Williams Resolution 09-11 adopted a Schedule of Civil Penalties for Parking Violations pursuant to Williams Municipal Code Section 10.33.010 and California Vehicle Code section 40203.5 on June 10, 2009; and,

WHEREAS, the City Council adopted Ordinance 188-11 establishing a permit parking program on November 16, 2011; and,







Per California Vehicle Code section 40226, in lieu of collecting a fine for a citation for W.M.C. 10.32.110, failure to display a disabled placard, the City may charge an administrative fee of \$25.00 to

process cancellation of a citation in any case where the individual who received the citation can show of that he or she had been issued a valid placard at the time the citation was received.

Late Payment Penalty: Any civil penalty not paid within 21 days of the date of the notice of violation (as fixed on the notice) shall incur an additional late payment penalty of 50% of the basic civil penalty.

Delinquent Penalty: Any civil penalty not paid within 15 days of the date of the notice of delinquent parking violation (as fixed on the notice) shall incur an additional penalty (in addition to the late payment penalty) of 50% of the basic civil penalty.

Costs of Collection: If a civil penalty shall become delinquent and the City pursues collection of the civil penalty, then, in addition to the total civil penalty, late payment penalty, and delinquent penalty, there shall also be added to the amount due the city's actual costs of collection of the delinquent penalty, including but not necessarily limited to debt collection agency fees and costs, attorney's fees, court costs, and City staff time and expenses.
